Covenant Statement and Coach/Volunteer/Board Member Application, January, 2008

The members of Park Sharon Athletic Association are committed to providing a safe and secure environment for all children/youth and volunteers who participate in sports sponsored by PSAA. The following policy statements reflect our commitment as an organization to make PSAA's facilities a place of safety and protection for all who would come to participate in its sporting events.

1. No adult who has been convicted of child abuse (either sexual abuse, physical abuse, or emotional abuse) should volunteer with children/youth in any PSAA sponsored activity.
2. All adult volunteers involved with children/youth must register online for a criminal background check. And such volunteers do agree to wear PSAA Identity badge when on the grounds of PSAA or representing PSAA in a sponsored activity.
3. Adult volunteers with children/youth shall observe the 'Two-Adult Rule' at all times so that no adult is ever alone with children/youth.
4. Adult volunteers with children/youth shall attend regular training and educational events provided by PSAA to keep volunteers informed of Association policies and state laws regarding child abuse.
5. Adult volunteers shall immediately report to a Board member, another coach or Sports Commissioner any behavior that seems abusive or inappropriate.
